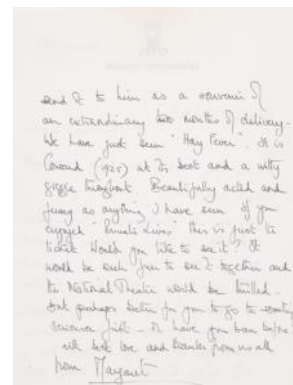
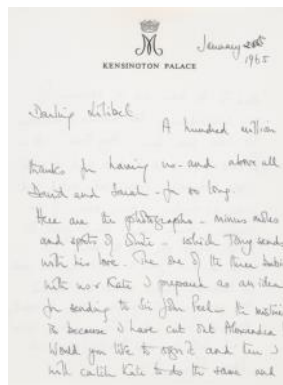

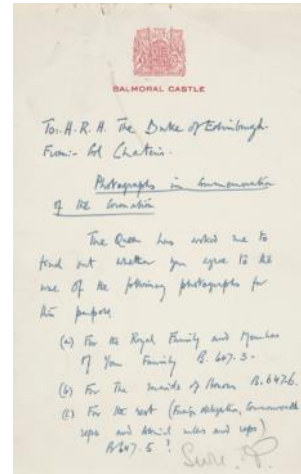

### **DACS usage restrictions for Andy Warhol, *Reigning Queens (Royal Edition): Queen Elizabeth II of the United Kingdom*, 1985:**

Press use is moderate use of artworks which would be considered to be fair dealing with an artwork (other than a photograph) to report a current event, or fair dealing with an artwork for the purpose of criticism or review, as specified in the Copyright, Designs and Patents Act 1988 c. 48 Section 30 Subsections (1) - (3). Uses of artworks which comply with the provisions in this section would therefore fall under an exception and do not need to be licensed for the limited specified uses. All other uses should be licensed. Due to the territorial nature of copyright law, prior authorisation may need to be sought for any press uses outside of the UK.

In addition, please ensure that all artworks are shown in full, with no cropping, overprinting or manipulation. Sufficient acknowledgement identifying the artwork and copyright holder is also required and DACS can provide you with the correct copyright by-line (contact details below).

Non-press use of artworks, highly commercial uses which are not considered to be 'fair dealing' or press uses where the above criteria do not apply (including, but not limited to, covers and feature articles; your own printed or online publicity materials; etc) must be licensed before use by the Design and Artists Copyright Society (DACS) as representative of the copyright holder.
